# COMMUNIQUE ON THE PREVENTION OF UNFAIR COMPETITION IN IMPORT

(COMMUNIQUE NO: 2014/5)

### Content

**ARTICLE 1-** (1) The communiqué contains the announcement of the anti-dumping measurements which will be expired by the second half of 2014 within the law concerning the Prevention of Unfair Competition in Import dated 14/6/1989 and numbered 3577, the decision of the council of ministers concerning the Prevention of Unfair Competition in Import dated 20/10/1999 and numbered 99/13482, and the regulation concerning the Prevention of Unfair Competition in Import published in the official gazette dated 30/10/1999 and numbered 23861.

# The effective expiry periods of the anti-dumping measures

**ARTICLE 2** – (1) The duration of the anti-dumping measures which remains in force, shall expire on the dates specified right across, in the following table.

# Final review of applications and processes

ARTICLE 3 – (1) According to the 35<sup>th</sup> article of the regulation of "Prevention of Unfair Competition in Import", prior to the expiry dates of the anti-dumping measures, the domestic manufacturers of the related products or the natural/ legal entities who act on behalf of that local production sector will have the right to demand a final review investigation because the termination of such measures will result in the continuation or the re-occurrence of the dumping and its damage. It is mandatory for the domestic manufacturers of the related products or the natural/ legal entities who act on behalf of that local production sector to support their applications for a final review investigation with sufficient evidence.

(2) Written applications supported by sufficient evidence must be submitted three months prior to the end of the relevant measures;

- (3) If the application is deemed within the relevant legislation, the "final review investigation" will be launched.
- (4) Existing anti-dumping measures will remain in force until the conclusion of the investigation.
- (5) If the final decision of the investigation will determine that the termination of the measure will likely lead to the continuation or re-occurrence of the dumping and its damage, the current anti-dumping measure will be pursued while maintaining or changing its amount or ratio. On the other hand, if the termination of the measure will not cause the continuation or re-occurrence of the dumping and its damage, the existing measures against dumping/ the compensatory measures against subvension shall be repealed.

# Operative effect

**ARTICLE 4** - (1) This Notification shall come into force on the date of its publication.

**ARTICLE 5** – (1) Economy Minister executes the provisions of this communiqué.
